<b>Description:</b>	AGOLIN NATURAX L is a blend of flavouring compounds for animal nutrition, designed for all animal species. Appearance: yellow-brown Structure: liquid Odour: rosemary like
<b>Active ingredients:</b>	AGOLIN NATURAX L is a carefully balanced combination of essential oil compounds in their natural form, GMO free. All active substances are of high purity and are accepted for use under current European animal feed and human food legislation and comply with the current regulation on organic production (EC 834/2007 and EC 889/2008).
<b>Carrier materials:</b>	All carrier compounds of AGOLIN NATURAX L are natural and comply with the current regulation on organic production (EC 834/2007 and EC 889/2008).
<b>Mode of action:</b>	AGOLIN NATURAX L has high antioxidant effects.
<b>Utilisation:</b>	For feed production only.
<b>Recommended dosage:</b>	250 – 1000 ppm, depending of the oxidative character of the product
<b>Storage:</b>	Store in a dry place and at less than 25°C. Once opened, contents should be used within a short period of time. Carefully seal the package after each withdrawal. Avoid storage of AGOLIN NATURAX L in plastic or plexiglass containers.
<b>Expiry date:</b>	18 months after production.
<b>Palatability:</b>	At the recommended dosage AGOLIN NATURAX L is readily accepted.
<b>Compatibility:</b>	AGOLIN NATURAX L carries no known incompatibilities with other commonly used feed additives such as yeasts, probiotics, etc.
<b>Tolerance:</b>	At three times the recommended level, feed intake might be reduced.
<b>Safety for non-target animals:</b>	AGOLIN NATURAX L presents no known risk to non target animals.
<b>Packaging:</b>	AGOLIN NATURAX L is available in 20 kg containers or in 200 kg drums
<b>Quality control:</b>	AGOLIN NATURAX L is subject to a strict quality control procedure before release for distribution.
<b>Health and safety data sheets:</b>	Available upon request.

For EU countries, AGOLIN NATURAX L is classified as a premixture of flavouring compounds in line with EU legislation including Regulation (EC) 1831/2003 on additives for use in animal nutrition and Directive 2002/32/EC on undesirable substances in animal feed.

For the United States, all flavour ingredients contained in AGOLIN NATURAX L are FDA approved.

Furthermore, all flavouring compounds used in the AGOLIN products are approved for food and appear on the FEMA/GRAS lists.
