### AGOLIN TANNIN

<b>Description:</b>	AGOLIN TANNIN is coated chestnut extract for animal nutrition. Appearance: dark brown Structure: free flowing, micro-beads Odour: woody
<b>Active ingredient:</b>	AGOLIN TANNIN consists of encapsulated natural chestnut extract, containing min. 75 % of hydrolysable tannins. The active substance is of high purity and is accepted for use under the current European animal feed legislation.
<b>Mode of action:</b>	AGOLIN TANNIN helps to optimise feed intake.
<b>Utilisation:</b>	For feed production only.
<b>Recommended dosage:</b>	250 - 750 mg/kg of feed for poultry, pigs and ruminants.
<b>Incorporation:</b>	AGOLIN TANNIN should be incorporated into premixes prior to mixing in feed in order to ensure a homogenous distribution.
<b>Storage:</b>	Store in a dry place at room temperature. Once opened, contents should be used within a short period of time. Carefully seal the package after each withdrawal.
<b>Expiry date:</b>	18 months after production.
<b>Stability:</b>	AGOLIN TANNIN is stable in premixes, concentrates as well as in mash, pelleted or expanded feed.
<b>Palatability:</b>	At the recommended dosage AGOLIN TANNIN is readily accepted.
<b>Compatibility:</b>	AGOLIN TANNIN carries no known incompatibilities with other commonly used feed additives such as yeasts, probiotics, etc.
<b>Tolerance:</b>	At three times the recommended level, feed intake might be reduced.
<b>Safety for non-target animals:</b>	AGOLIN TANNIN presents no known risk to non-target animals.
<b>Packaging:</b>	AGOLIN TANNIN is available in 25 kg paper bags and in big bags of 500 kg.
<b>Quality control:</b>	AGOLIN TANNIN is subject to a strict quality control procedure before release for distribution.
